Selection Committee

Our committee will include seven members this year, including two Garden representatives, the past two winners, and three representatives from key Central Arizona Conservation Alliance partners - Maricopa County Parks, McDowell Sonoran Conservancy, and the Sonoran Institute.

Our Past Winners

In 2018, we honored Tamara Woodbury for her pivotal leadership as the CEO of the Girl Scouts–Arizona Cactus-Pine Council; her work has led to the connection of countless young women to nature. It was also under her guidance that the Bob & Renee Parsons Leadership Center for Girls and Women at Camp South Mountain was opened to serve the Arizona community in 2017.

The first Award for Excellence in Conservation was bestowed on Mayor Jackie Meck in 2017 for his visionary leadership in Buckeye, which emphasized the protection of the city's open spaces for residents, and included his involvement in the formation and management of the White Tank Mountains Conservancy.
